OCTOBER 2012 MEETING MINUTES

Eta Delta Chapter of The Delta Kappa Gamma Society International held its regular meeting on Saturday, October 6, 2012, in the home of Michelle Smith. President Bonnie Moore and Recording Secretary Shirley Moan were present when President Bonnie Moore called the meeting to order at 9:55 a.m.

Bonnie welcomed our newly initiated members – Leigh Elizondo, Kathy Froehlich, and Kirbe Hunt. They were initiated into The Society prior to the beginning of today's business meeting.

INSPIRATIONAL MESSAGES

There were two Inspirational Messages given at the meeting.

- 1. Jane Flinn read "Thanks for..." by an unknown author in the absence of Helen Shoup. We all felt that it served as a tribute to Helen's late mother and our beloved sister, Allene Holman.
- 2. Michelle Smith honored her late mother, Beatrice Smith, by sharing a synopsis of her mother's life, especially her impact on the lives of the young children she taught.

CORRESPONDENCE

Secretary Shirley Moan read the correspondence that had been received since our last meeting.

- A thank you note from Shirley Moan thanking the chapter for awarding her the Chapter Alpha State Convention Scholarship for her first State Convention.

Bonnie next explained that two of our members have requested to change their membership status to Reserve Member. Bonnie explained the requirements for Reserve Membership status. She then asked for Finance Committee Chairman, Shirley Moan, to explain the dues that Reserve Members are expected to pay.

Therefore, Shirley made the following recommendation: Reserve Members of Eta Delta Chapter shall be required to pay \$28 for International and State dues and \$18 for Chapter fees which is a total of \$46. If the Reserve Member wants the chapter newsletter mailed to them, they should add an additional \$5

Bonnie asked for a second to the motion. It was seconded. Since there was no discussion, Bonnie called for the vote. The motion was approved.

TREASURER'S REPORT

Treasurer Nancy Malone reported a balance on hand of \$3961.15. The balances of the Scholarship CD and the Grant-in-Aid CD are \$\$7,168.43 and \$6,306.98 respectively. The Treasurer's Report was accepted and filed for audit.

Nancy also announced that she had filed IRS form 990N with the State Treasurer. She also announced that Form 15 was sent to the State Treasurer by Shirley Cousins, former treasurer, before the July 15th deadline.

PRESIDENT'S REPORT

Bonnie announced that Eta Delta had received the following awards:

- 1. Yearbook: Jane Flinn, last year's yearbook chairman, earned the chapter the Early Bird and Exemplary Awards.
- 2. Newsletter: Ann Mahan earned the chapter the 5-Star Award for her outstanding newsletter.

HISD's Community Partner of the Year Award Bonnie read the letter from Red Elementary's Principal thanking Eta Delta for our continued support of Red's library whose librarian is our own Michelle Smith. Members have made donations to the library for several years. Michelle uses these extra funds to buy the Bluebonnet Series books. Michelle nominated us for this award.

Bonnie also asked for our assistance in completing the Chapter Wellness form that will be due. During this time, we also discussed our Goals for the Year.

Jane also announced that we'll be collecting our change from now until March for Schools for Africa. We each received a collection box to fill and bring to the Birthday Luncheon in March.

 - d. Our attendance for today's meeting is 14 present, 18 absent, and 1 death (Allene Holman).
 - e. We have two members Berta Deleza and Helen Lewis who have requested Reserve Membership. According to the Guidelines from DKG, Reserve Membership shall be granted to a member who is unable to participate

fully in the activities of the chapter due to physical disability and/or geographical location. Since both Berta and Helen have physical disabilities that prevent them from participating fully in chapter activities, the Membership Committee moved that Berta Deleza and Helen Lewis be granted Reserve Membership status.

Bonnie asked for and received a second to the motion. There being no discussion, the vote was taken, and the motion was approved.

3. Communication:

for Allene Holman. Bonnie said she would check with Helen about when she would like for us to hold the service for her mother.
